



**REQUIREMENTS FOR THE IMPORTATION OF BREEDING SWINE**  
**FROM DENMARK INTO THE KINGDOM OF THAILAND**

- 1) **A health certificate** in English signed by a full-time authorized veterinary official of the government of the exporting country stating:-
  - 1.1) number and species,
  - 1.2) breed, sex, age and color,
  - 1.3) animal identification,
  - 1.4) name and address of the owner/exporter, and identification premises of origin,
  - 1.5) certification of condition items (3) to (14).
- 2) **Pedigree certificate** shall accompany the imported animals, for breeding purpose, on arrival.
- 3) The animals must originate from areas which are not under restrictions due to animal diseases. They are found to be healthy, free from signs of any infectious and contagious diseases including ectoparasites at the time of export and fit to travel.
- 4) The country of origin is free from African Swine Fever, Transmissible Gastroenteritis (TGE) and Rinderpest.
- 5) According to the OIE standards, the country of origin is free from Foot-and-Mouth Disease, Classical Swine Fever, Brucellosis and Aujeszky's Disease, and vaccination against these diseases is not carried out.
- 6) The animals must originate from premises, in which there for the past 12 months prior to departure have been no clinical cases of Tuberculosis, Brucellosis in swine, Leptospirosis, Swine Vesicular Disease, Vesicular Exanthema, Porcine Parvovirus Infection, Teschen's disease, Transmissible Gastroenteritis(TGE), Atrophic Rhinitis, Toxoplasmosis, Trichinosis, Trichinosis and Swine Influenza. No increased occurrence of clinical signs of Streptococcus suis type 2 infections in the last 3 months has occurred. For the past 2 years prior to departure have been no clinical cases of Procine Reproductive and Respiratory Syndrome (PRRS), and vaccination against the disease is not carried out;

- 7) The animals have been kept isolated on the premises of origin under official supervision with no contact to animals of lower health status, for a period of 30 days prior to export.
- 8) Each individual animal must have within the 30 days isolation period, using accredited test methods been tested with negative results for the following diseases:-
  - 8.1) Porcine Respiratory and Reproductive Syndrome (PRRS)
  - 8.2) Atrophic Rhinitis
- 9) Shortly prior to departure the animals must be clinical healthy and without visible signs of ectoparasites.
- 10) Prior to departure the animals must be vaccinated against Porcine Parvovirus. Animals younger than 5 months are not vaccinated against the disease, but descend from dams vaccinated against Porcine Parvovirus.
- 11) Prior to departure the animals must be treated with Dihydrostreptomycin with a dose and duration effective for Leptospirosis.
- 12) The vehicles and containers used for transporting the animals must have prior to loading been thoroughly cleaned and disinfected or heat-treated.
- 13) The accommodation, provided for the animals during transport, is in compliance with the EU legislation in force on animal welfare.
- 14) During transport no additional feed or fodder is allowed to be added to the vehicles.
- 15) The animals are subjected to quarantine at approved premises, for a period of not less than 30 days upon arrival, during which they shall be submitted to tests and/or treatment deemed necessary. The importer/owner shall be fully charged for the incurred expenses.
- 16) Failure to follow the import procedures may result in returning the animals to the country of origin or destroying without compensation.
